Commissioners Bunderson and Ramey discussed the previous meeting with Ms. Wescott and the fact that no further information has been provided by BFD with regard to co-staffing Station 18 and/or a new BFD Station on Gary Lane. Mr. Paul Henning from the Whitney Fire District stated that the Whitney Fire District may not be obtaining an impact fee study.
