- 1) Fund AEDs in public areas like The Merc, Clubhouse, Library, Pools, etc...
- 2) Conduct training for the public in basic first aid and CPR
- 3) Utilize Pulse Point in the outlying areas
- 4) Organize and support CERT team
- 5) Possibly co-staff a QRU for Stations 18 and 20
- 6) Possibly co-staff with ACP for medical coverage in Station 18's area

PREVENTION DEPARTMENT UPDATE - Fire Marshal Romeo Gervais

Operational Permit Fees and Consideration to Adopt an Updated Fee Schedule

Fire Marshal Gervais revisited the previous conversations with the Board regarding aligning Operational Permitting Fees and Construction Permitting Fees with those of Boise Fire Department. ACCELA is going live May 21st for Operational permitting. Operational Permit fees will increase while construction permitting fees are likely to go down. There will be some additional Operational permit fees added as they are new in the 2015 NFPA. Fire Marshal Gervais asked the Board to review the handouts, and he will work with District Administrator Young to come up with a new fee schedule for adoption.

District Administrator Young will get information on Idaho Code for increasing permit fees. A public hearing will be required.
