This notice contains a statement of the estimated revenue from property taxes, and the total amount from sources other than property taxes, and also contains the proposed expenditures by fund for Fiscal Year 2023. The proposed budget is based on preliminary tax revenue estimates received by the District from the Counties and is subject to adjustment at the public hearing based upon final tax revenue figures which are anticipated to be received from the Counties prior to the budget hearing.


