### **Boise Fire Department Report - Assistant Chief Romeo Gervais**

**Darkhorse Software** – New Analytic software is being implemented which will provide future call for services and development information. Meridian Fire already uses this software, and it has been useful for modeling.

**Station 13** – Station 13 is in progress. A July opening date is the goal. Station 13 crews will move into Station 18 in late April/early May.

Div. Chief Carbone - Chief Carbone has announced his retirement in April of 2025.

### **Eagle Fire Department Report – Deputy Chief Jamie Vincent**

**Station 5 Generator** – The generator project at Station 5 is set to be completed this Wednesday. Scheduling issues with Idaho Power and the Electrician have slowed the process.

**Gym Apparatus** – New gym apparatus has been ordered for Station 5.

**New Engine 45** – The E-45 "new engine kinks" have been worked out with the exception of an engine brake issue.

**Brush Trucks** – Brush trucks have been ordered through Corwin Ford and contracts have been signed.

**Eagle Station 4** – EFD will be breaking ground on Eagle Station 4 at Eagle road and Colchester. It will be a 2-story station. It is anticipated it will take 9 months to build and should open in the spring of 2026.
