* Consideration to approve NACFR Resolution #78

A resolution of the board of commissioners of the North Ada County Fire & Rescue District, Ada County, State of Idaho, making certain findings and expressing the Board of Commissioners' intent to withdraw the North Ada County Fire & Rescue District from the Garden City Urban Renewal Agency's Revenue Allocation Area described in attachments 1 and 2 of the River Front East Urban Renewal Project urban renewal plan established and referenced in Ordinance No. 954-12 of the City of Garden City; and directing the Secretary; and providing an effective date.

Boise Station 13 crews will be rehoming into Station 18. June 16 is the finish date for Station 13. ACHD will be doing additional work to cover the ditches surrounding the Station on State and Bogart. Station bidding for crews at Station 13 has begun.

The Fire Chief's Conference will begin at the end of this week in Sun Valley. Idaho State Fire Commissioners Conference is concluding at the end of this week, and the Idaho Fire Chiefs have invited Officers of ISFCA to attend the Idaho Chiefs Conference.

Call Volume Data was distributed to the NACFR Board and the Eagle Fire District Assistant Chief Theron Hudson. The data was discussed with all who were present. Chief Hudson and Chief Gervais will collaborate on a specific data set that might provide the NACFR Board with call volume information they requested.
